CAST

JUDGE JOHNSON - JP MS. ANDERSON - TIFFANY MARY - HOLLY MS. EDWARDS - KRISTIN JURY MEMBER 1 - MITCH JURY MEMBER 2 - JAPO JURY MEMBER 3 - PHIL

> (A courtroom. MS. EDWARDS is standing at the center of the court. MARY is at the stand.)

MS. EDWARDS

...And so, the defendant is clearly guilty. The evidence against her is insurmountable. Destruction of property. Evading a police officer. Her blood was found on the dashboard of the car. So I ask you, esteemed members of the jury, to do what is right. I rest my case.

(MS. EDWARDS returns to her seat.)

MS. ANDERSON Your Honor, we'd like to cross-examine the defendant.

JUDGE JOHNSON

I'll allow it.

(MS. ANDERSON stands at the center of the court.)

MS. ANDERSON

Ms. Davidson, you had a... Sexual relationship with the victim, yes?

MARY Technically, yes. But it's complicated.

MS. ANDERSON Complicated, you say? And why is that? MARY

I'm asexual.

(The court is aghast. They murmur to each other. "Peas and carrots.")

JUDGE JOHNSON Okay, I'm interested. Asexual, you say?

MARY

That is correct. I don't experience sexual attraction.

JUDGE JOHNSON

Wonderful. Love is love. Now, the court is free to ask the defendant any questions regarding the matter at this time.

Very good, very good. My niece watched <u>But I'm a Cheerleader</u> last weekend. Any more questions?

JURY 1 Maybe you just haven't found the right thing you're into, yet? I never felt any type of attraction for a long time. And then I saw the tiger from <u>Zootopia</u>.

MARY I don't know what you're referencing, I've never seen <u>Zootopia</u>.

JURY 1 Well- There's your problem! I mean, case closed, right?

MS. EDWARDS Is asexual genetic, or can anyone get it?

JURY 3

Did you know that the song "Take Me to Church" was about sex?

MARY

Yes.

JURY 3

Okay. How did you know? Because I just found out last week and I do <u>not</u> want to get caught off-guard again.

MARY

Alright, could we hurry this up? My mom is coming to visit me at the prison today and I'd prefer to be in a good mood for that.

JUDGE JOHNSON And she has a healthy relationship with her mother! A win for the community!

(Every hand in the room is up. JUDGE points to JURY 2.)

JURY 2

I've never had sex, does that mean I'm asexual?

MARY

Do you want sex?

JURY 2

Yes, but no one has ever wanted to do it with me.

MARY You're not asexual, you just can't pull bitches.

JURY 2

Ahhhhhhh. I see. Thank you, defendant.

MS. ANDERSON

We have time for one more question. Is that cool, your honor?

JUDGE

Yeah, yeah, yeah - Cool with me. I'm just chilling, learning, listening. One might say <u>I'm</u> being an ally-

(The room applauds.)
